INTRODUCTION

Corona Research is pleased to present this report of future direction survey findings to the State of Colorado Department of Natural Resources. The following report includes a description of the project background, survey methodology and implementation, along with a summary of key survey findings and detailed findings.

BACKGROUND AND OBJECTIVES

Colorado State Parks retained Corona Research to undertake a complete study of marketing issues related to Colorado's state park system, as an assessment of the needs, preferences, and priorities of its constituents. Specifically, Corona Research was obtained to conduct a comprehensive and systematic research project that identifies Colorado State Parks' position in the outdoor recreation marketplace, and to provide information for the future direction of Colorado State Parks by identifying the facilities, services, and programs valued by citizens of Colorado and visitors to Colorado State Parks. This research, undertaken in the 2008/2009 time period, includes public surveys, intercept surveys of park visitors, a future direction survey of park visitors, focus groups with visitors and non-visitors to state parks, and an economic impact analysis.

THIS REPORT

This report contains findings specific to the visitor future directions survey aspect of the project. The goal of this phase of the research was to examine visitors' attitudes towards the future directions they feel should be taken by Colorado State Parks and assess visitors' preferences for future enhancements and additions within the state park system. Philosophical user preferences, specific park enhancements and detailed questions regarding visitors' preferences towards funding sources and fee structures were also examined in the future directions survey. A goal was set to collect 200 intercept surveys at five strategically selected Colorado State Parks over a year long sampling period. The five parks selected to participate in this portion of the study were Castlewood Canyon State Park, Chatfield State Park, Eleven Mile State Park, James M Robb State Park and Mueller State Park. Overall, a total of 1,136 total future directions surveys were collected for the study, and an average of 227 surveys were collected for each park.

The following report details the visitor future directions findings for each question on the survey. Further detail by park is presented as an appendix to the report.

SURVEY METHODOLOGY

Colorado State Parks and Corona Research worked together to design a future directions survey instrument which best captured visitors' perceived needs, enhancements, and strategic long-term goals regarding the future directions of Colorado State Parks. All surveys were distributed by Colorado State Parks Rangers and Volunteers to state parks visitors on-site at each of the five strategically selected future directions parks which were selected to be representative of all Colorado State Parks. The survey instrument is provided for the reader in **Appendix A**. Execution of the survey took place from August, 2008 through July of 2009.

Prior to survey implementation, the Corona project team met with park rangers from each of the participating state parks to develop an optimal sampling plan for each state park. Each sampling plan was tailored to capture survey responses from visitors at a number of specific sites determined with ranger input for each park. Specifically Corona Staff met in-person with Colorado State Park Rangers from each to identify the following sampling plan components:

1. The most heavily trafficked entrance points within each park
2. Times during the day when visitation was highest and lowest
3. Proportional visitation rates (by season) during Weekends and Weekdays (based on official visitation statistics provided by Colorado State Park Senior Staff)
4. Visitation rates within each park by month

After consulting with Park Rangers from each park regarding these different components of the sampling plan, Corona Staff then put together final sampling plans specifically tailored to each park with the goal of gathering the most statistically reliable survey sample for each park. Each park had their own specific sampling plan which also took into account any seasonal variations noted by Park Rangers regarding visitation rates. Final survey sampling goals were created which informed Park Managers when, where and how many surveys were to be collected at different times of day, different days of the week/weekend and at different sites within each park throughout the survey execution phase of the project proportional to visitation estimates.

Sampling goals were also developed for each park by season. Seasonal visitation numbers were used to determine the total number of surveys that would be collected for each park. These seasonal visitation percentages used in the study are detailed below:

Season	Months	Visitation Percentages
Summer	May - August	63%
Fall	September - October	16%
Winter	November - February	13%
Spring	March - April	8%

Interpreting the table above, each park attempted to gather 63 percent of their total number of surveys collected during the summer sampling period, 16 percent of all surveys collected were to be conducted during the fall sampling period...etc. It should be noted that adjustments were made for parks that had seasonal park closures or other issues affecting seasonal visitation patterns.

The ultimate goal of this intricate survey sampling plan was to gather the most representative sample of visitors possible for each of the five parks participating future directions study. Colorado State Park rangers and volunteers handed out all surveys to park visitors and were trained by Corona Research Staff on the proper methods to properly execute random intercept surveys for the project. Training DVD's were created for park staff and the Corona Research Project Team gave survey implementation trainings at State Parks Regional Staff meetings prior to survey execution.

Great effort was required of Colorado State Parks Rangers and Volunteers to accurately implement such customized and detailed survey sampling plans at each park. Their dedication to this phase was crucial to the success of the overall project and it should be noted that the total number of surveys collected exceeded the original goal for all parks. As previously detailed, a total of 1,136 total future directions surveys were collected over a year-long sampling period. A list of total surveys collected at each park is provided below:

REPORTING NOTES

In reviewing the following report of findings, these notes are important to keep in mind:

- Figures in all graphs and tables have been rounded for reporting purposes. Due to this rounding, a bar graph occasionally may not add exactly to 100 percent. Also, this may cause some bars labeled with common values to have slightly different lengths.
- Labels on graphs for values of two percent or less have been removed for clarity in reading.
- Open ended survey responses are provided in the Appendices of this report by park, so that park managers from each of the five participating parks can easily assess what their visitors had to say for each open ended question regarding their specific park.

WEIGHTING NOTE

NOTE: The results presented below were not statistically weighted, as the future directions survey was designed to be a collection of surveys from five strategically sampled Colorado State Parks selected to be representative of all state parks. Final findings reported here were therefore not weighted with relationship to all state parks, but instead represent the total findings of all surveys collected at these five parks.

FINDINGS CAVEAT

NOTE: These surveys were conducted during a one-year time period from August 2008 through July 2009. Since each park represents an independent and geographically distinct natural area, it is possible, even likely, that some parks were facing extraordinary situations during the time period of the survey, which might include fires, pine beetles, drought, or other issues that might affect staff priorities or visitor perceptions.

KEY FUTURE DIRECTIONS FINDINGS

While many conclusions and implications can be drawn from the survey, several stand out as being of particular interest. These findings are discussed below. The corresponding exhibit number follows each finding.

1. **The five parks chosen for the study were indeed representative of all state parks.** Comparison questions with the Visitor Intercept Survey provided similar answers from survey respondents of the Future Directions Survey. A number of questions were asked at the beginning of the survey to compare the Future Directions survey sample with the Intercept Survey sample. Overall, findings were similar on comparison questions throughout the two different surveys. In total, 51 percent of Future Directions visitor survey respondents paid daily entrance fees while 46 percent used an Annual Pass, which was similar to the 47 percent of visitors in the Intercept Survey who used daily entrance fees and the 46 percent who used an Annual Pass of some sorts. Findings between the Future Directions and Intercept Surveys mirrored each other for overnight visitation, overall quality of experience at the state park, and customer service ratings. The only notable difference was seen in contact with state park staff. Visitor survey respondents in the Future Direction survey were notably more likely to have had contact with Colorado State Park staff than in the Intercept Survey (86 percent vs. 69 percent). On the whole, however, it was noteworthy that survey responses between the two different surveys mirrored each other so well. This is a strong sign that the five strategically selected parks chosen to participate in this portion of the study were a good sampling of all state parks. *Exhibits 1-1, and 1-4 through 1-8.*
2. **Clean parks, good weather and trails were the phrases most commonly associated with a perfect state park experience.** The words and phrases most commonly used to describe the perfect experience at a state park included good weather, clean facilities and good trails to recreate on. Also, visitors most frequently cited participating in a recreational activity that can only be done in a natural setting, relaxing to get away from the normal stresses of life and spending quality time with their family or friends as their top goals for their visit to a Colorado State Parks. In total, over half of all visitors ranked those three goals in their top three goals for their current visit and over one-third of all visitors rated participating in a recreation activity that can only be done in a natural setting as their top goal for their current trip. *Exhibits 2-2 and 2-3.*
3. **A majority of visitors felt rising fuel costs would have little to no impact on their visitation to state parks.** Overall, 53 percent of visitors said there would be negligible impacts on their state park visitation due to rising fuel costs. However, it's noteworthy that one-quarter of all visitors did say that rising fuel costs would cause them to take fewer visits, while just 15 percent of visitors indicated that rising fuel costs would either increase or prolong their visits to Colorado State Parks. Therefore, if a prolonged surge in fuel prices were to occur in the U.S. an overall decrease in Colorado State Parks visitation would be expected. *Exhibit 2-4.*
4. **Additional wildlife viewing areas was a desired future feature by park visitors.** When asked about a number of potential new features and its effect on visitation, visitors most frequently indicated that additional wildlife viewing opportunities would increase their visitation and would

be pleasing to them as a future change to the park(s). Overall, 59 percent of visitors said this would increase their visitation to state parks and 67 percent of visitors said they would be pleased with additional wildlife observation areas. Individual state parks might not be able to do much to increase the wildlife that habitat and visit their park, but if a known migratory pattern would enable the parks to promote seasonal increases in specific animal species, it could help to increase total park visitation and satisfaction levels. *Exhibits 2-5 and 4-1.*

5. **A majority of visitors preferred charging higher fees for specialized activities while keeping entry fees as low as possible.** When asked to choose between charging higher fees for specialized activities (such as boating, camping, etc...) and keeping entry fees as low as possible or increasing entry fees but keeping specialized fee rates lower, 66 percent of visitors preferred to charge higher fees for specialized activities. Only 19 percent of visitors supported keeping specialized activity fees low while increasing entrance fees. Additionally, a majority of visitors also felt that visitors who use more electricity at campsites should pay higher fees than visitors that use less electricity at campsites (61 percent). A general expectation among visitors existed regarding paying more for specialized features and services at Colorado State Parks. *Exhibits 2-7 and 3-3.*
6. **Visitors most frequently supported having a few premium facilities that cost extra and charged premium fees.** Overall, almost half of all visitors supported having a few premium facilities that had nice camp sites or cabins with electricity that cost more to access; whereas 36 percent of visitors felt facilities at all parks should be built to the same standards (and charged the same fees). Additionally, when asked if they would be willing to pay more for a heavily developed camp site or an undeveloped (more primitive camp site), a majority of respondents said they would be willing to pay more for the more developed camp site. *Exhibit 2-8 and 3-2.*
7. **Visitors would rather increase fees if it meant the conditions of facilities and natural resources were improved or upgraded.** When asked to choose between increasing fees to upgrade the conditions of park facilities, natural resources and activities or keeping all fees the same even if some facilities or natural resources might decline, 61 percent of visitors said they would prefer an increase in fees which helped improve facilities and natural resources. Contrarily, 20 percent of visitors wanted fees to remain the same even if resources and facilities might decline. *Exhibit 2-10.*
8. **A majority of park visitors felt increased recycling efforts should be a priority of Colorado State Parks.** When asked about potential energy improvements that could take place at state parks, 75 percent of visitors felt the provision of more and separate recycling containers at state parks should be either a high or moderate priority compared to other park operations. A majority of park visitors also thought that installing energy producing wind or solar power sources in out of the way areas to power the park or sell on the grid should be at least a moderate priority. Upgrading the energy efficiencies of state park buildings and vehicles were seen as lower priorities among visitors. *Exhibit 2-14.*
9. **Visitors most often preferred a park with primitive campsites with more space and privacy than a park with developed campsites.** When asked to choose between two hypothetical parks (a developed park vs. a more primitive park), almost half of all visitors preferred the more primitive (and private) park, whereas just 23 percent indicated that they preferred more highly developed state park (the remaining visitors

preferred both park types equally). However, when asked which state park they would be willing to pay more for, a 58 percent said they would pay more for the highly developed park. This further bolsters a pay as you go system. *Exhibits 3-1 and 3-2.*

10. **Colorado State Parks have lots of competition for their visitors' time.** When asked where they would go if the state park they were currently visiting was not available, visitors most frequently indicated they would go to another state park (25 percent). However, it was noteworthy that there were several substitute competitors visitors indicated they would also likely go to if that state park was no longer available. National forest areas (22 percent), neighborhood parks (15 percent), "Other" natural outdoor areas (12 percent), and national parks (10 percent) all received a mixture of support from visitors. *Exhibits 3-6.*
11. **The internet was the most frequently used information source for leisure activities among park visitors.** Overall, 45 percent of visitors said they most often get information regarding leisure activities from the internet. Similarly, when asked where they specifically get information about activities at the state park they were visiting, the second most frequently cited park-specific information source was the State Park website (18 percent). Only past experience at the park was cited more frequently as a park-specific information source (32 percent). *Exhibits 3-8 and 3-9.*
12. **Visitors would be most pleased with new land and trails as future park changes.** When asked how they would perceive a number of potential future park changes, visitors most frequently indicated that they would be pleased with additional park land and new/expanded hiking and walking trails (72 percent of visitors would be pleased with each change). Also noteworthy, additional isolated primitive campsites were also frequently rated as pleasing to visitors (49 percent). *Exhibit 4-1.*
13. **Visitors were most familiar with entrance and activity fees as funding sources for state parks.** A large majority of visitors identified entrance fees (86 percent) and activity fees (82 percent) as funding sources used to support the agency. A high percentage of visitors also identified the lottery (56 percent) and general state tax dollars (48 percent) as funding sources for Colorado State Parks. Also noteworthy, 80 percent of park visitors said they thought Colorado State Parks should receive funds from general state tax dollars. Overall knowledge of state park funding sources was reasonably high among visitor respondents. *Exhibits 4-4 and 4-5.*

SECTION 1: STATE PARK BACKGROUND QUESTIONS

In section 1, survey respondents were asked a number of questions detailing the logistical nature of their visit. Specifically, visitors were asked to describe the main reason they decided to visit, the pass type they used on their visit, their overall quality of experience at the state park during their visit and questions related to Colorado State Park employees customer service during the visit.

It should be noted that the majority of questions in Section 1 were also asked in order to check the overall reliability and ability to generalize findings from the Future Directions survey sample with that of the entire Colorado State Park system. Therefore, the majority of questions asked in this section were also asked in the visitor survey so that comparisons between the answers of visitor respondents in both surveys could be assessed.

On the whole, final findings for the duplicate questions asked between the two surveys (intercept survey and future direction) mirrored each other. This is a strong sign that the five strategically selected parks chosen to participate in this portion of the study were a good sampling of all state parks.

**PASS TYPES USED BY VISITORS
WERE CLOSE TO EQUALLY
DIVIDED AMONG
RESPONDENTS**

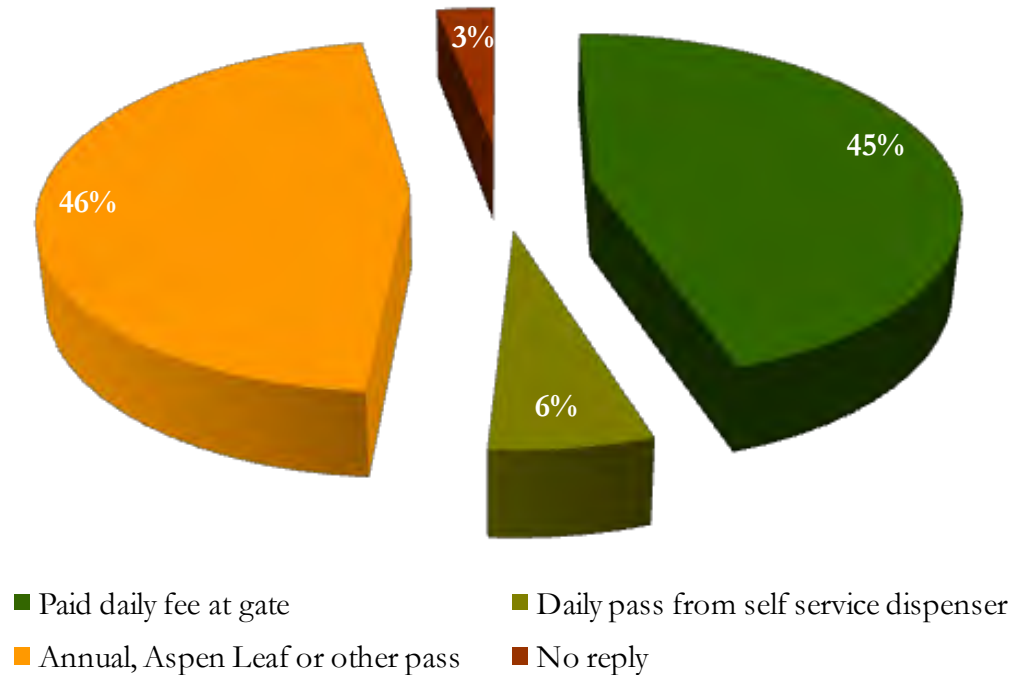
Overall, visitor survey respondents' pass type usage during their visit was fairly equally divided. In total, 45 percent of visitors who took the Future Directions survey paid a daily entrance fee at the gate, while an additional 6 percent of visitors used daily passes from self service dispensers. Contrarily, 46 percent of all visitors used an annual pass of some sorts (Annual pass, Aspen Leaf pass or some other yearly pass).

These findings also reflected the findings for pass type used in the larger intercept visitor survey (see intercept survey report for full details). In the larger intercept survey, 47 percent of visitors used a daily pass and 46 percent used an Annual Pass of some type which generally mirrors the findings shown in Exhibit 1-1.

NOTE: Annual pass holders have more repeat visits, so this is unrelated to sales.

VISITORS MOST FREQUENTLY FELT THEIR VISITATION TO STATE PARKS HAD REMAINED THE SAME IN THE PAST YEAR

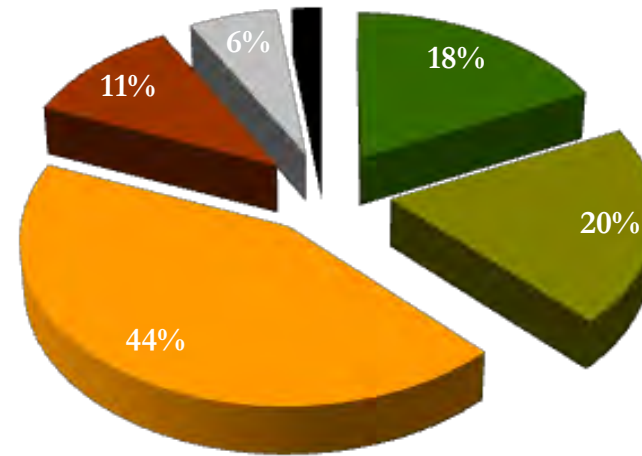
When asked to compare their visitation to state parks in the current year with their visitation levels in previous years, visitors in the future directions survey most often felt their visitation levels had remained about the same (44 percent).

Interestingly, over one-third of all visitors who completed the future directions survey indicated that they had visited state parks either much more or somewhat more in the past year, while 17 percent of visitors indicated they had visited state parks less in the past year.

It should be noted that frequent visitors would be more likely to be handed a survey for completion, and therefore the increased visitation numbers presented in Exhibit 1-2 are possibly inflated due to this increased likelihood of surveying frequent visitors.

OVER ONE-THIRD OF VISITORS PLANNED ON STAYING OVERNIGHT IN THE PARK

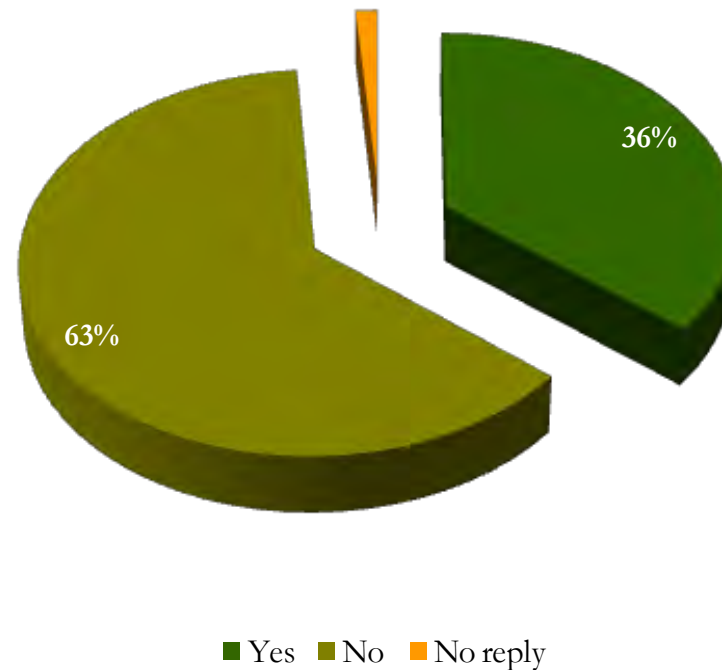
Overall, 36 percent of visitors indicated they planned on staying overnight in the park where they took the survey. Contrarily, 63 percent of visitors were day trippers.

It should be noted that these findings mirrored the findings from the larger intercept survey (conducted in every state park), where 38 percent of survey respondents said they would be staying overnight in (or near) the park.

These and other findings on the following pages serve as a confirmation that the five parks surveyed in the Future Directions survey are reasonably representative of all state parks.

VISITORS RATED THEIR QUALITY OF EXPERIENCE DURING THEIR VISITS VERY HIGHLY

When asked to describe their overall quality of experience at the state park where they were surveyed on their visit, visitors rated their experiences very highly.

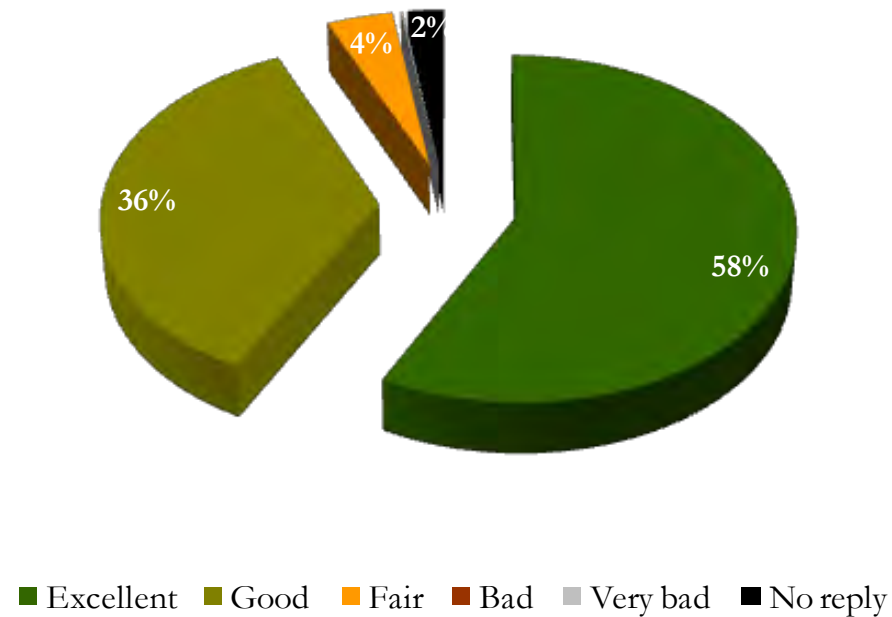
In total, 94 percent of all visitor survey respondents rated their experience as either excellent or good (with over half of all visitors rating their experience with the top possible rating).

It should be noted that these quality of experience ratings mirrored the quality of experience ratings found in the intercept visitor survey conducted across all state parks (where 92 percent of visitors rated their experience as either excellent or good).

These and other findings on the following pages serve as a confirmation that the five parks surveyed in the Future Directions survey are reasonably representative of all state parks.

A LARGE MAJORITY OF VISITORS HAD CONTACT WITH STATE PARK STAFF

Overall, 86 percent of all visitors surveyed in the future directions survey said they had contact with Colorado State Parks staff on their visit. Only 11 percent of visitors indicated they had no contact with park staff.

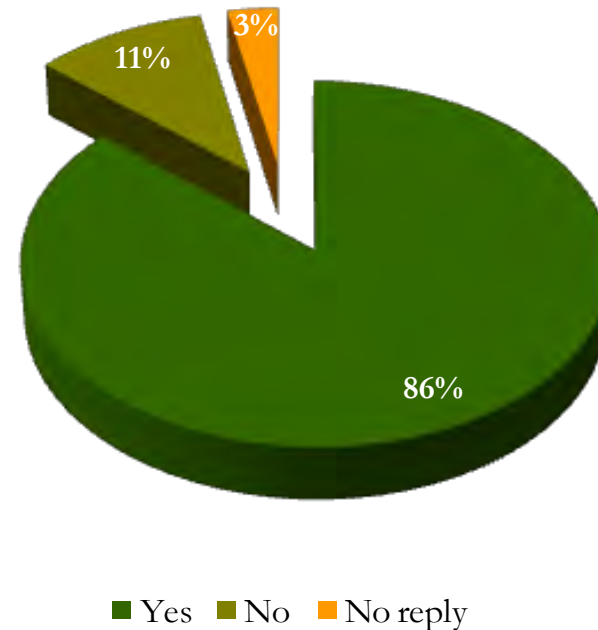
It should be noted that this was the only survey question where a notable difference was observed between visitors who took the intercept visitor survey and this future directions survey.

Visitors in the future directions survey were notably more likely to have had contact with state park staff (86 percent, compared to 69 percent in the intercept visitor survey).

Despite these findings, the other findings detailed within Section 1 serve as a confirmation that the five parks surveyed in the Future Directions survey are reasonably representative of all state parks.

VISITORS RATED CUSTOMER SERVICE VERY HIGHLY

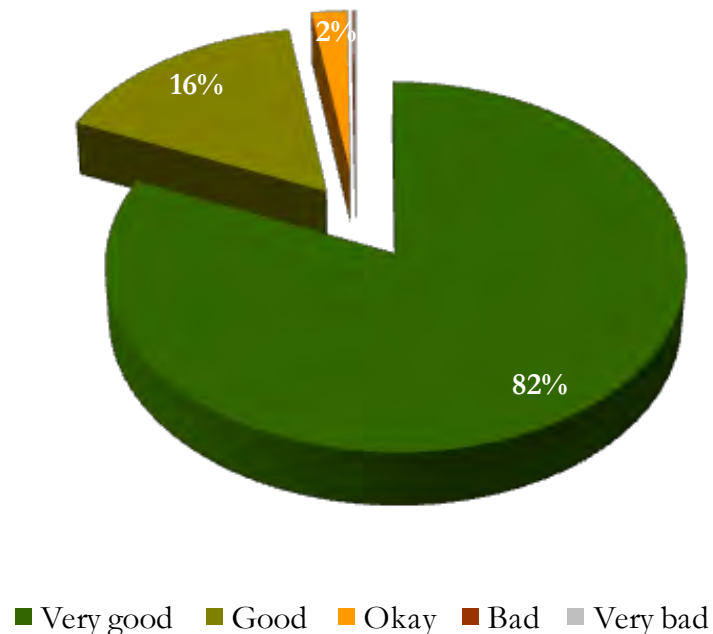
Overall, 98 percent of all visitors who participated in the future directions survey rated customer service as either very good or good, and over 80 percent of all visitors gave Park Staff customer service the top possible rating (very good).

These findings were nearly identical to visitor findings from the visitor intercept survey conducted at all state parks.

These and other findings detailed within Section 1 serve as a confirmation that the five parks surveyed in the Future Directions survey are reasonably representative of all state parks.

OVER ONE-THIRD OF VISITORS WHO DIDN'T HAVE CONTACT FELT IT WOULD HAVE BEEN BENEFICIAL

Of the visitor survey respondents who indicated they did not have contact with Park Staff, 35 percent felt that contact with Park Staff would have been beneficial during their visit.

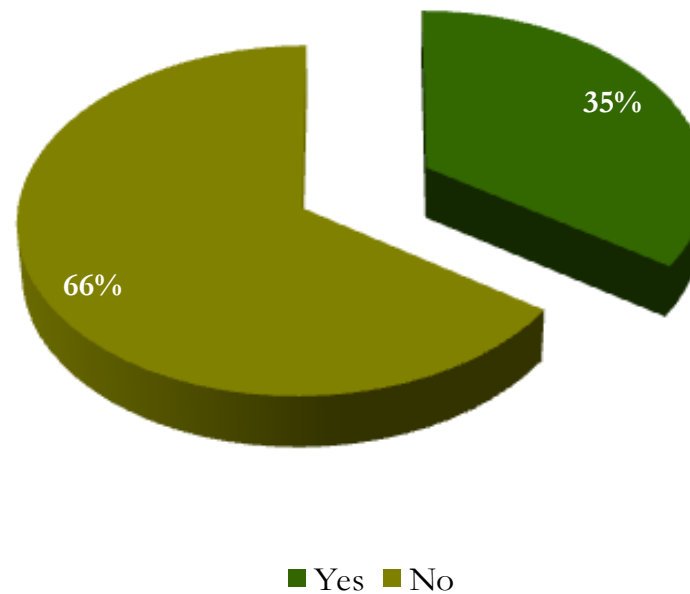
Contrarily, the majority of visitors who didn't have contact indicated they did not feel it would have been beneficial (66 percent).

These findings were nearly identical to visitor findings from the visitor intercept survey conducted at all state parks.

These and other findings detailed within Section 1 serve as a confirmation that the five parks surveyed in the Future Directions survey are reasonably representative of all state parks.

SECTION 2: VISITOR PERCEPTIONS AND PREFERENCES

In Section 2, survey respondents were asked a number of questions aimed at better understanding visitor perceptions, goals and preferences relating to Colorado State Parks features. Specifically, visitor survey respondents were asked to describe their perfect experience at a state park to qualitatively assess what things are essential to visitors in providing a quality experience at a state park.

Additionally, visitors were asked to give their perceptions and preferences regarding fee structures, potential future features at state parks, visitor goals and preservation of park natural resources.

A MAJORITY OF VISITOR SURVEY RESPONDENTS CAME UP WITH THE IDEA TO COME TO THE PARK THEMSELVES

When asked who first had the idea to come to the state park the day they were surveyed, 55 percent of all visitor survey respondents said they were the ones who decided to visit the park (and answer of “Me”).

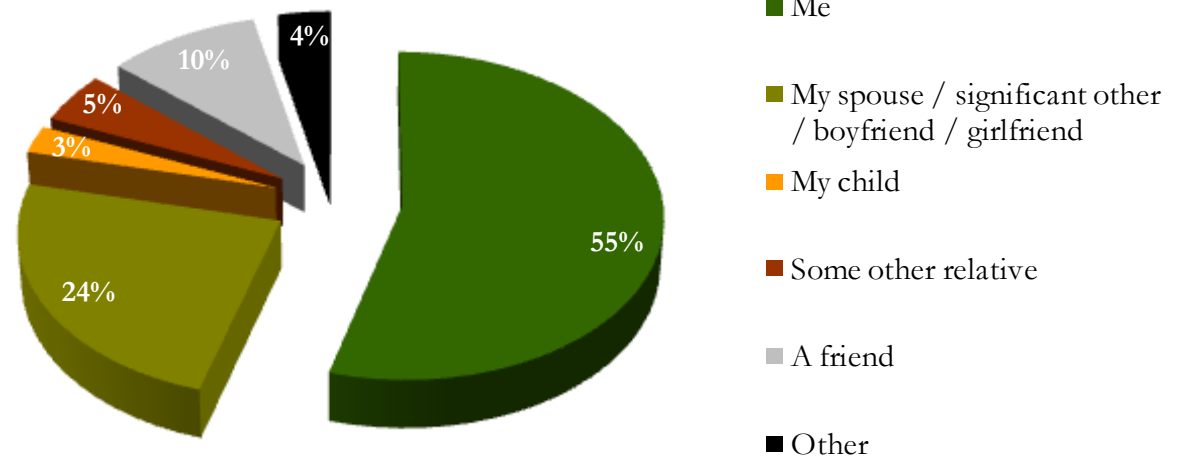
An additional 24 percent indicated their spouse or significant other thought of coming to the park, and that was why they had come for their visit.

One-tenth of respondents cited “a friend” as the person who had the first idea to visit the state park.

Subsequent follow-up analyses showed that men were more likely than females to indicate that they first had the idea to come to the park, while females were notably more likely to cite their “spouse / significant other” or “a friend” as the person who first had the idea to come to a Colorado State Park.

PARTICIPATION IN OUTDOOR RECREATIONAL ACTIVITIES WAS THE MOST COMMON TOP VISITOR GOAL

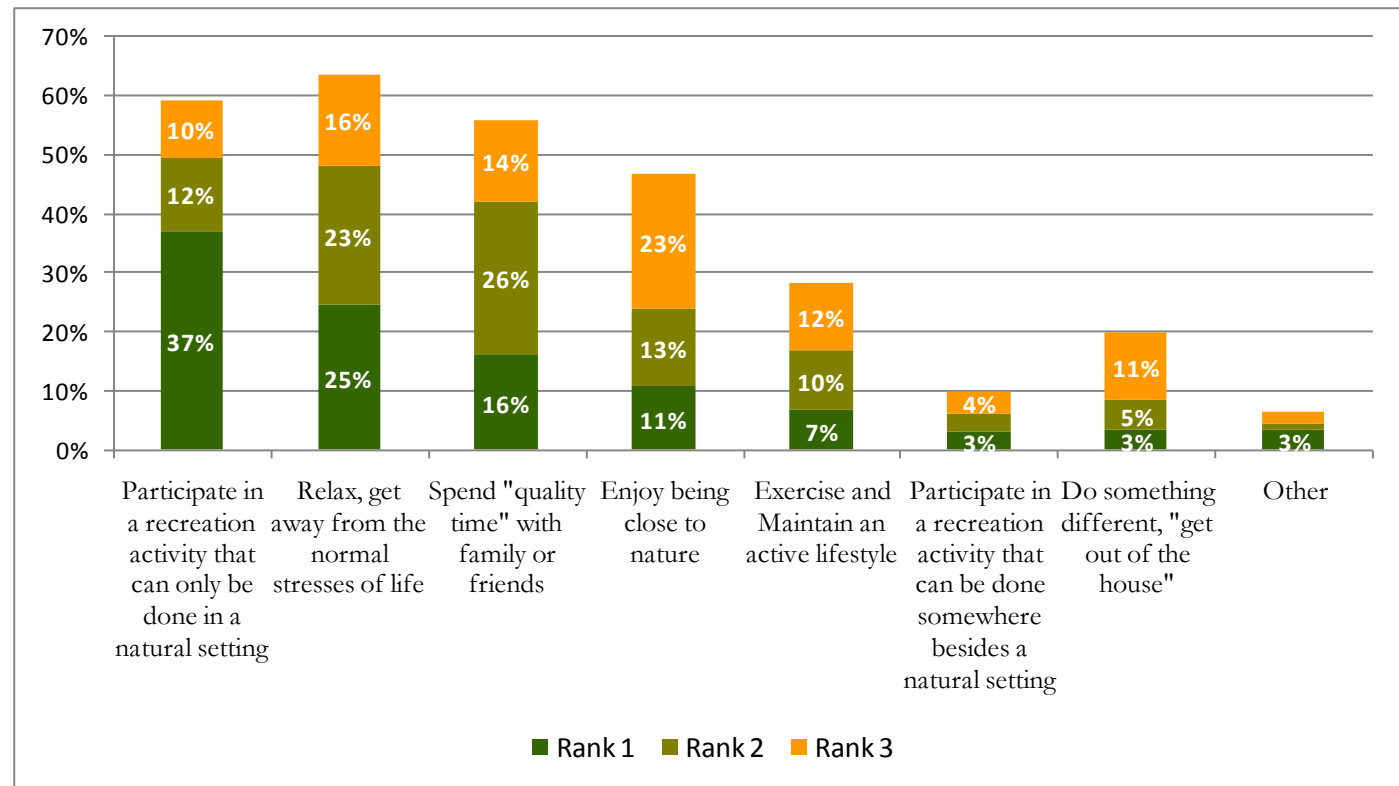
When asked to select their top three goals for their current visit to a state park, visitors most frequently ranked the following goals with their top three rankings:

1. Participate in a recreation activity that can only be done in a natural setting (37 percent of visitors gave this their top rating, 59 percent ranked it in their top three);
2. Relax and get away from the normal stresses of life (64 percent of respondents ranked this goal in their top three);
3. Spend quality time with family or friends (received a ranking from 56 percent of visitors).

The goal “Enjoy being close to nature” was also frequently rated at with a number of visitor’s top three rankings

OVER HALF OF ALL VISITORS FELT RISING FUEL COSTS WOULD HAVE NEGLIGIBLE IMPACTS ON VISITATION

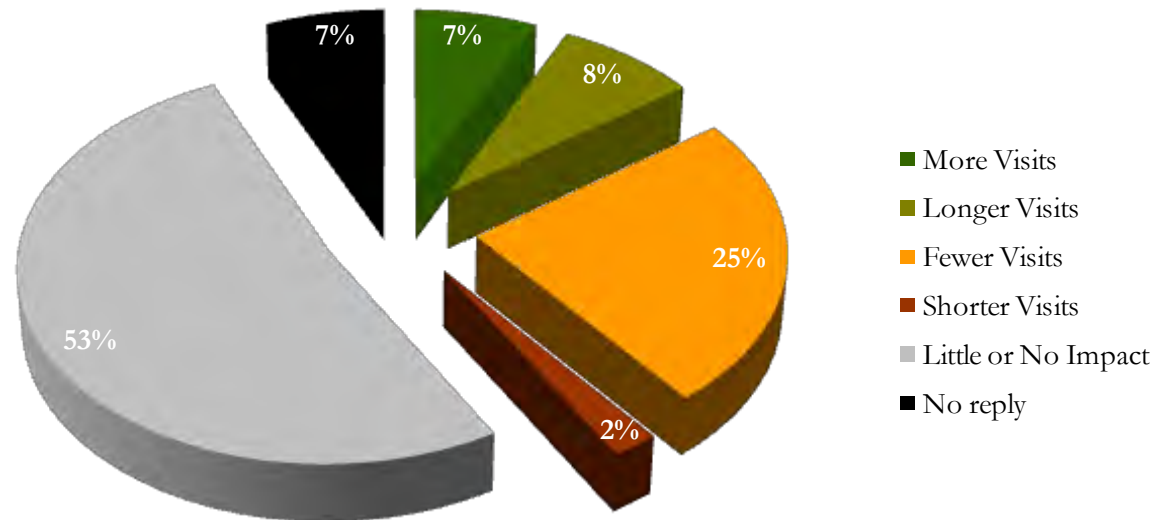
When asked how rising fuel costs would impact their state park visitation, a majority of all visitors felt rising fuel costs would have little to no impact on their visitation to Colorado State Parks.

However, it should be noted that one-quarter of all visitors felt that rising fuel costs would result in fewer visits to state parks. Contrarily, seven percent of visitors felt they would take more visits (presumably as a substitute for other more distant destinations) while eight percent said it would elongate their visits.

Only two percent of visitors felt rising fuel costs would make them take shorter visits to Colorado State Parks.

When asked how a number of potential park-related features would increase or decrease visitation, visitors most frequently indicated that their visitation would increase with “more wildlife viewing opportunities” and “cleaner facilities and park areas”.

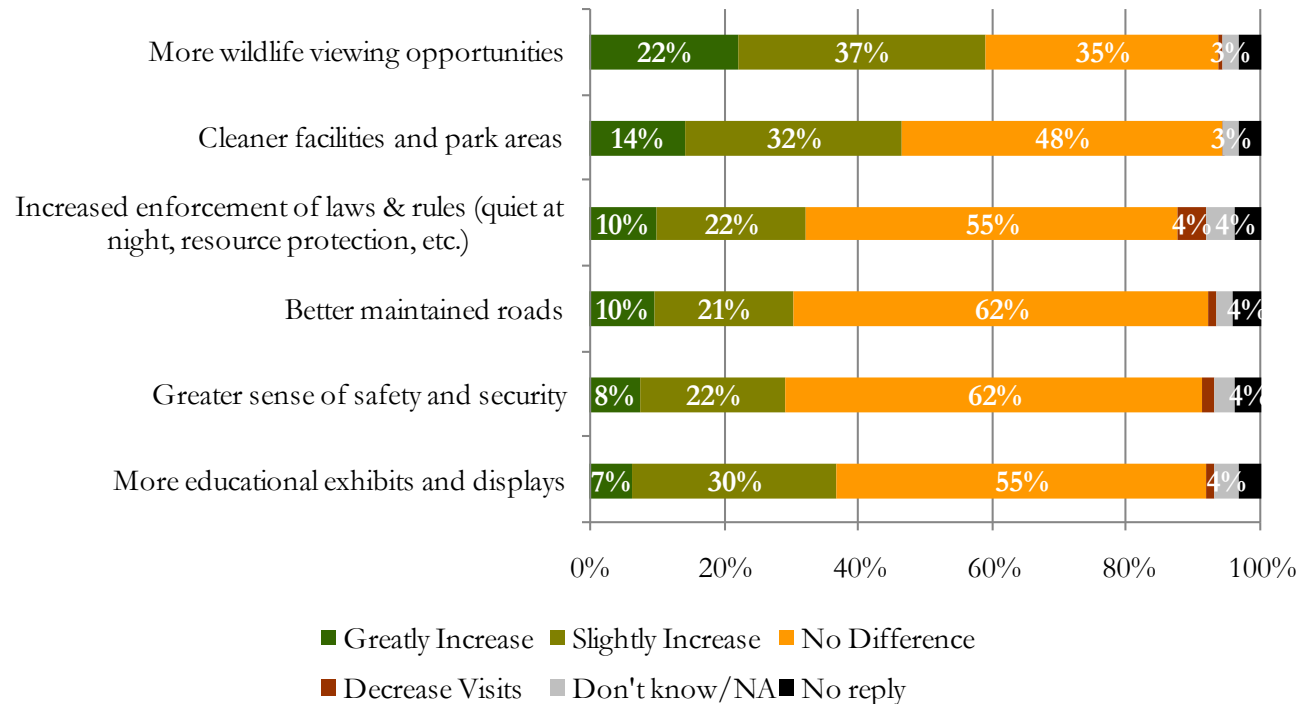
Overall, nearly a quarter of visitors said increased wildlife viewing opportunities would greatly increase their visitation (59 percent said it would at least slightly increase visitation).

Almost half of all respondents felt cleaner facilities and park areas would at least slightly increase their park visitation (46 percent). Increases to education exhibits, enforcement of laws and safety and maintained roads also received notable perceived increases in visitor visitation.

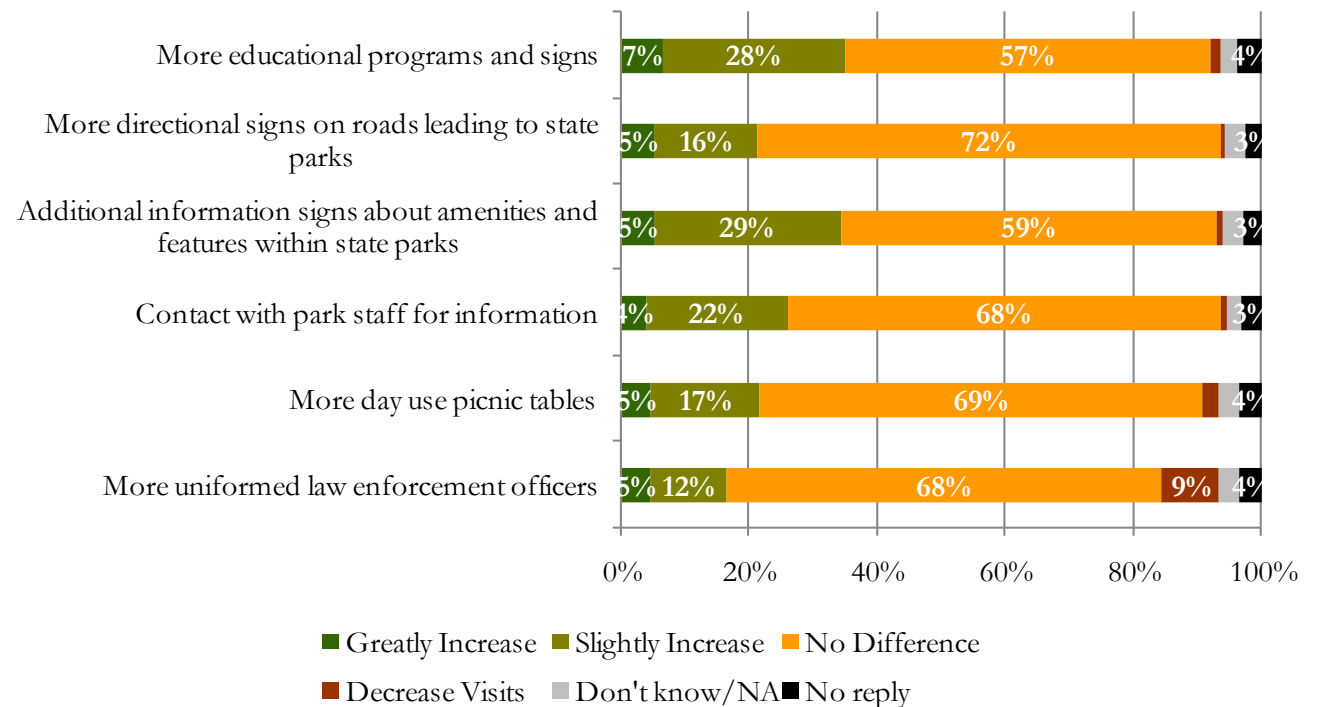
Almost one in ten visitors indicated that increases in uniformed law enforcement officers in Colorado State Parks would cause them to decrease their visitation to state parks.

A majority of visitors indicated their visitation levels would remain unchanged for all of the other features listed in the survey.

Though it's notable that over one-third of all visitors said more educational programs and signs and additional information signs about amenities/features within state parks would at least slightly increase their park visitation.

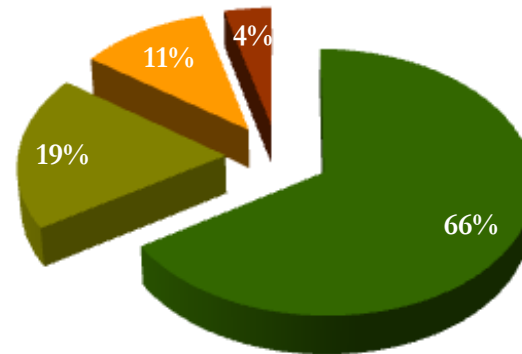
A MAJORITY OF VISITORS SUPPORTED CHARGING SEPARATE FEES FOR SPECIALIZED ACTIVITIES

Overall, 66 percent of all visitors said they supported keeping entry fees as low as possible and charging higher fees for specialized park activities (like camping or boating), while just 19 percent of visitors contrarily supported charging higher entry fees to ensure that specialized activity fees were kept low.

Eleven percent of visitors had no preference between the two options.

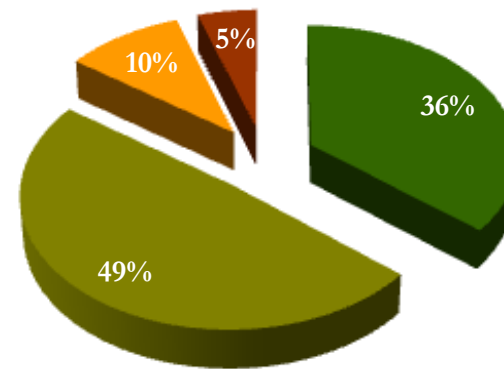
Overall, almost half of all visitors indicated that they supported having a few premium facilities (in the park system) that cost extra and are only available to those willing to pay premium fees.

Contrarily, over one-third of respondents felt all facilities should be built at the same standards and priced at the same fee structure.

One-tenth of visitors had no preferences regarding these two facility and fee structure philosophies.

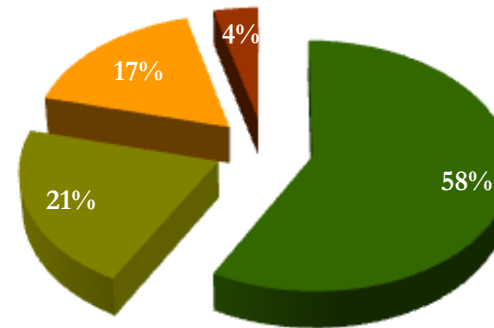
A MAJORITY OF VISITORS SUPPORTED INCREASING VOLUNTEER EFFORTS OVER HIRING MORE STAFF

In total, 58 percent of visitors supported increasing volunteering opportunities at the parks to maintain and improve facilities and conditions at the parks, while 21 percent of all visitors contrarily supported hiring more staff and spending more money to address park maintenance and natural resource issues.

Seventeen percent of all visitors had no preference between the two options.

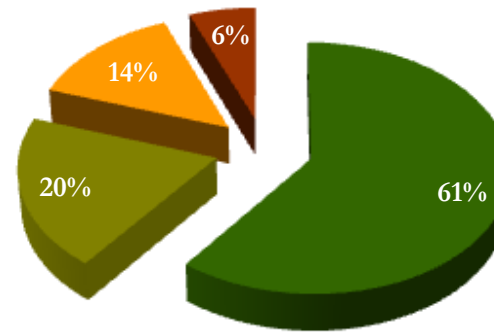

Overall, 61 percent of all visitors said they supported increases in fees at this park so that conditions of the facilities, natural resources and activities could be improved or upgraded.

On the other hand, 20 percent of visitors though fees should be kept the same, even if it meant that facilities and natural resources might decline.

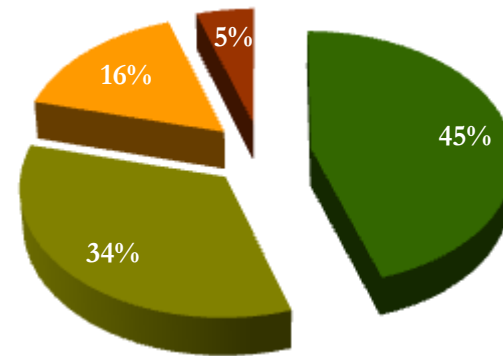

Overall, 45 percent of visitors said they supported parks providing more programs and activities aimed at helping educate kids and youth about nature and the outdoors, while 34 percent of visitors felt parks should let nature speak for itself and should not worry about providing additional educational programs for people.

Sixteen percent of visitors had no preference between the two options.

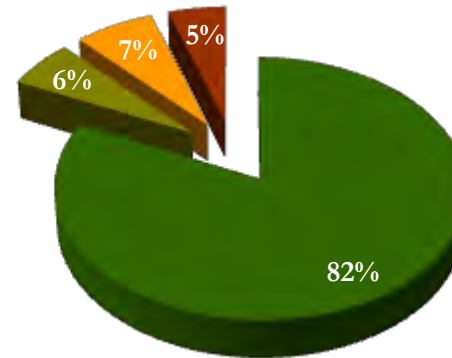

A significant majority of visitors (82 percent) felt parks should encourage park visitors to take a more active role in protecting the natural resources at the parks.

Only six percent of visitors felt that protection of natural resources should be left to the paid staff that manages the parks.

PROVIDING RECYCLING CONTAINERS AT STATE PARKS WAS THE TOP ENERGY PRIORITY

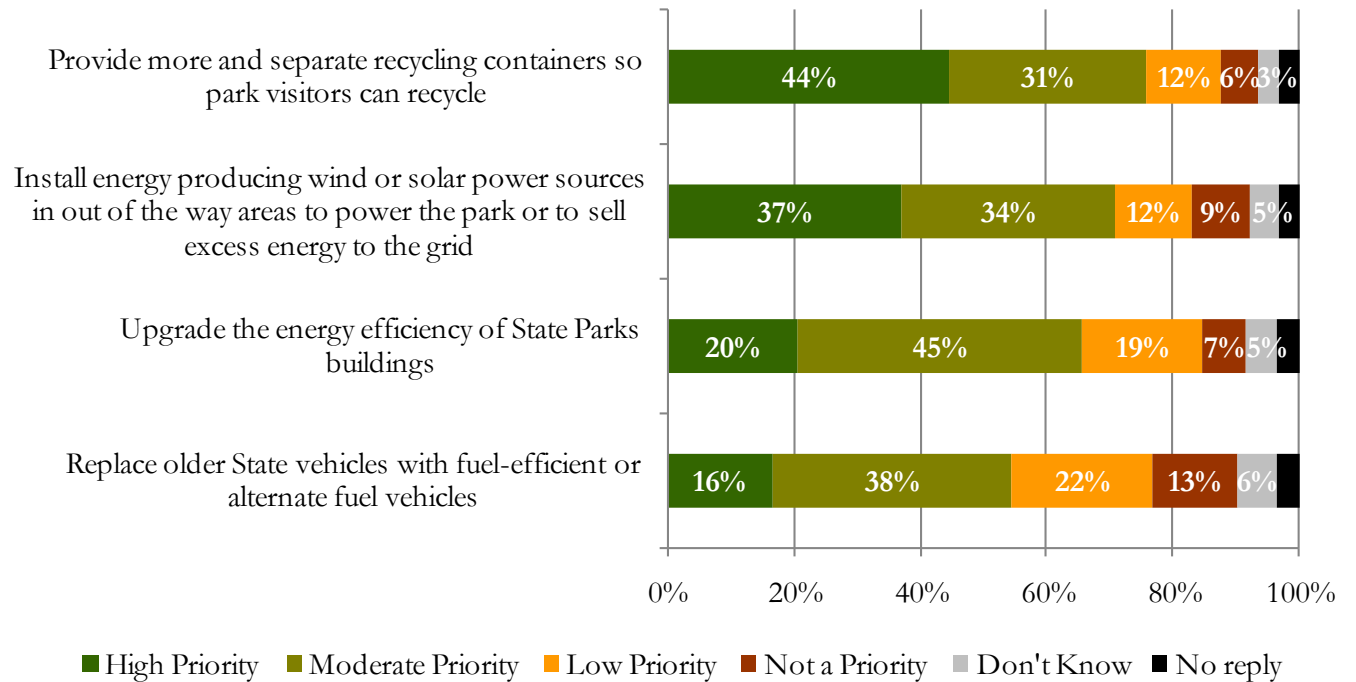
Overall, three-fourths of all visitors felt that providing more and separate recycling containers for park visitors to use at Colorado State Parks should be at least a moderate priority for state parks.

Installation of energy producing wind or solar power in discreet park areas to power the park or sell energy to the grid also saw strong support, with 71 percent of all visitors at least labeling this as a moderate priority.

Upgrading the energy efficiency of state parks buildings and vehicles were seen as lower priorities among visitors compared to the two highest ranked options, but it is noteworthy that a majority still felt they should be at least a moderate priority for State Parks.

SECTION 3: VISITOR PHILOSOPHIES AND INFORMATION SOURCES

In Section 3, philosophical questions regarding visitor's preferences for different types of park styles are detailed, as are visitors' decision making processes for coming to a state park. Specific questions are also asked with examine the information sources visitors utilize when selecting recreational activities and state parks.

VISITORS MOST FREQUENTLY FAVORED PRIMITIVE CAMPING DEVELOPMENT

When asked to choose between a developed park with plumbing and restrooms with showers (Park A) versus a more primitive campsite with no plumbing or electricity (Park B), visitors most frequently chose the less developed park option.

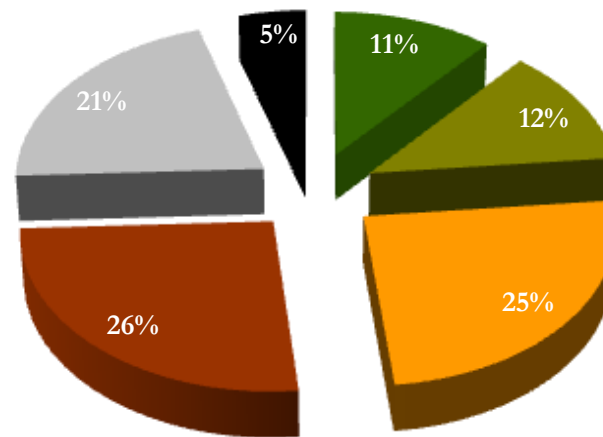
Overall, 47 percent of respondents preferred Park B either most of the time or all of the time, while 23 percent of visitors said they would prefer Park A at least most of the time.

An additional one-quarter of visitors said they had equal preference for the two different hypothetical park options.

VISITORS WERE WILLING TO PAY MORE FOR A PARK WITH MORE DEVELOPED AMENITIES

When visitors were asked what they would be willing to pay for each of the hypothetical parks detailed in question 16, a majority of visitors indicated they would be willing to pay more for the more developed park.

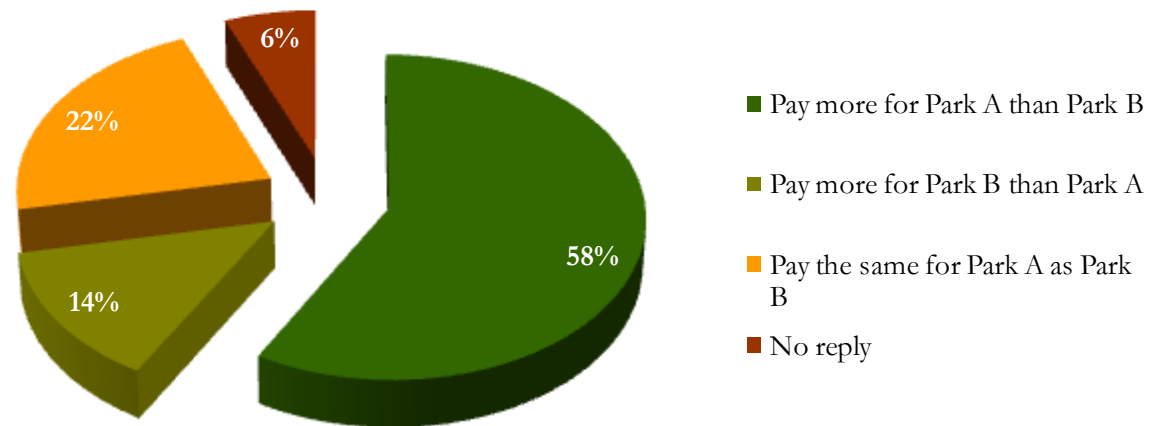
In total, 58 percent of all visitors said they were willing to pay more for Park A than Park B. Interestingly, 14 percent of visitors indicated they would pay more for Park B than Park A.

Ultimately, this it is important that visitors reiterated that they would be willing to pay more for a park with more amenities and reaffirmed the findings detailed in Question 13b (Exhibit 2-8) where they indicated they would prefer to have some parks with more amenities that visitors would have to pay more to access.

Note that the previous exhibit also indicated a preference for the less developed park.

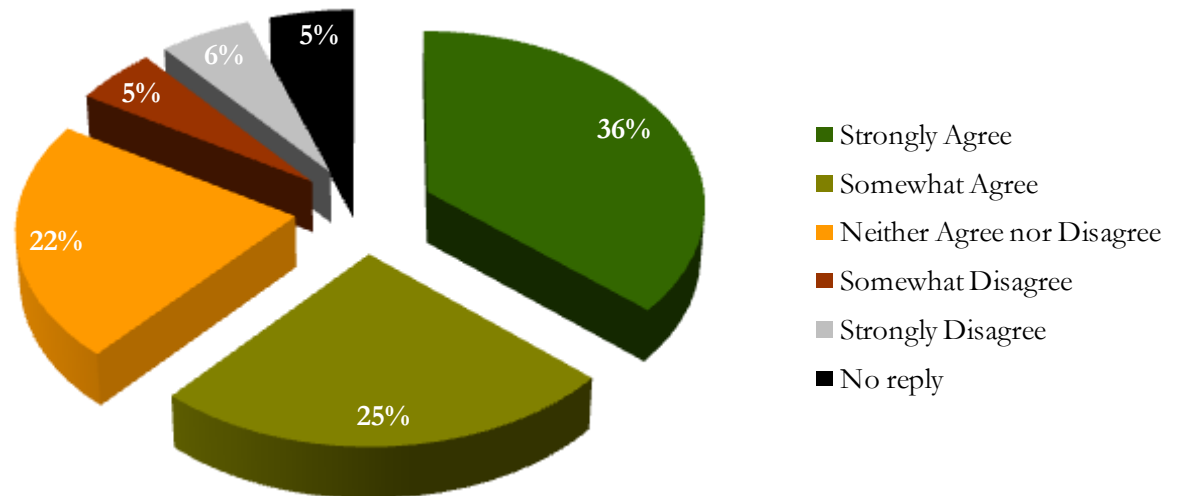

Overall, 61 percent of all visitors indicated that they either somewhat or strongly agreed that those visitors who use less electricity at campsites should pay lower fees than visitors who use more electricity.

In contrast, on 11 percent of visitors disagreed with this statement while 22 percent indicated that they neither agreed nor disagreed with the statement.

(Question 18) Please mark one choice for how you feel about the following statement: Those who use less electric at a campsite should pay a lower fee for that campsite than those who use more electric?



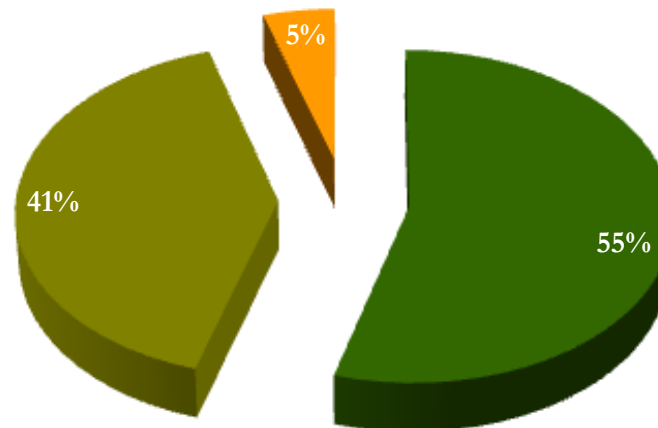

In Question 19, visitors were asked to philosophically assess their decision process for coming to a state park. Overall, 55 percent of visitors indicated that they typically decide what activities they want to participate in (hiking, fishing, etc...) and then decide that a state park is a good place to do that activity.

In opposition, a strong minority of visitors said they decide first that they would like to visit a state park and then decide on the activities they are interested in pursuing during their visit.

When visitors were asked where else they would have gone if the state park they were currently visiting was not available, their responses were diverse and wide ranging.

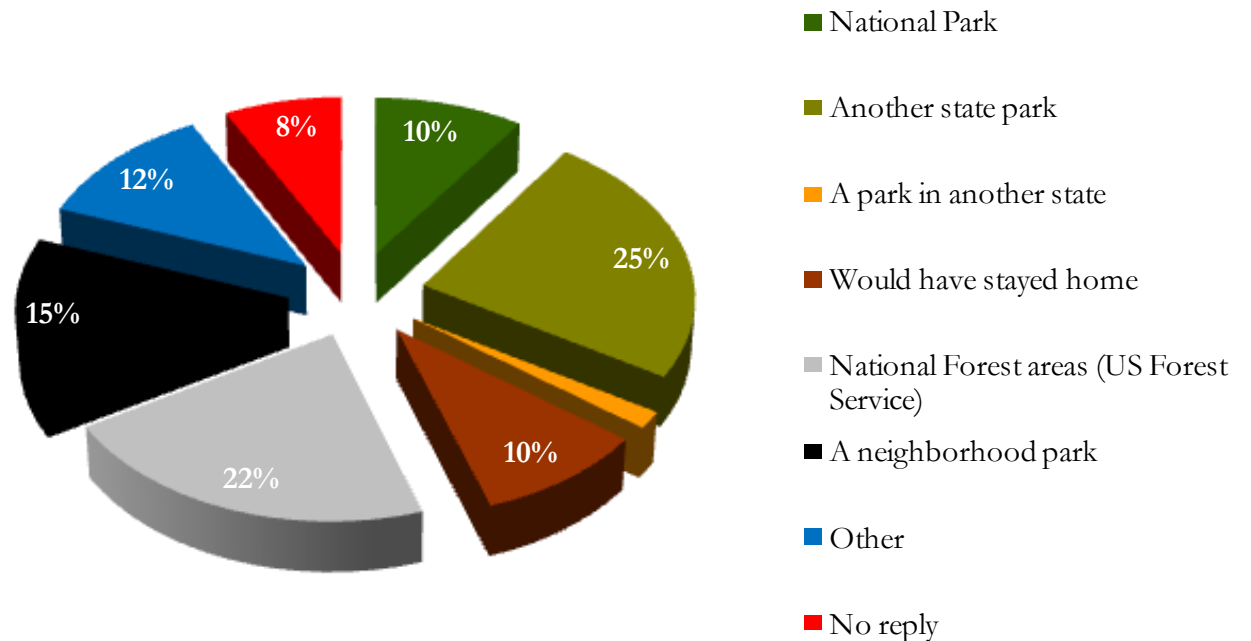
Overall, visitors most frequently said they would go to another state park if the current one they were visiting were unavailable (25 percent).

Other options frequently selected included: National Forest Areas (22 percent); A neighborhood park (15 percent); and "Other" options (12 percent).

It's encouraging from a Colorado State Park perspective that visitors most commonly said they would go to another state park, but the wide range of support for other options highlights the competition Colorado State Parks faces for its visitors time.

PROXIMITY TO HOME WAS THE TOP CRITERIA CITED BY VISITORS

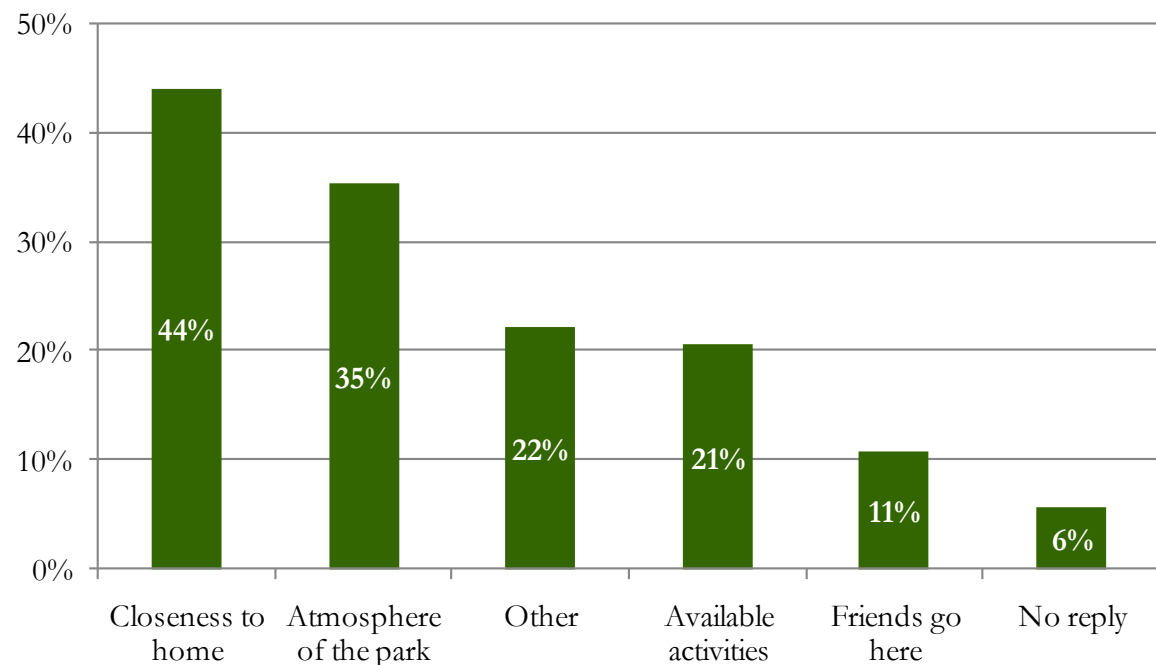
When asked why they choose a state park over other possible destinations, visitors most frequently indicated that the state parks close proximity to their home was a factor in their decision (44 percent).

Other factors frequently cited by visitors included atmosphere of the park (35 percent) and available activities (21 percent).

PREVIOUS EXPERIENCE IN A STATE PARK WAS A COMMON INFORMATION SOURCE FOR VISITORS

Overall, nearly one-third of respondents said they received most of their information about activities at the state park from their previous experiences at the park.

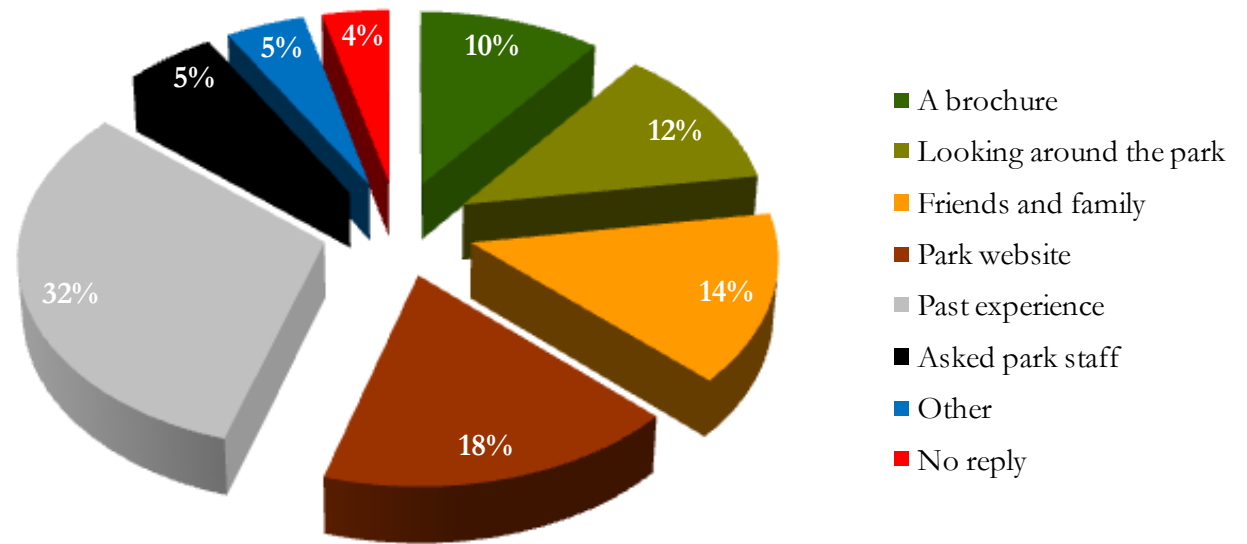
As noted earlier, repeat and high volume visitors were possibly more likely to participate in the survey, so citation of past experience as an information source could be elevated for this question.

The Colorado State Park website was the second most frequently cited information source (18 percent), while friends/family (14 percent) and just looking around the park (12 percent) were also commonly cited by visitors.

It should be noted that one in ten visitors said they got their information from a park brochure.

INTERNET WAS THE TOP INFORMATION SOURCE FOR LEISURE ACTIVITIES

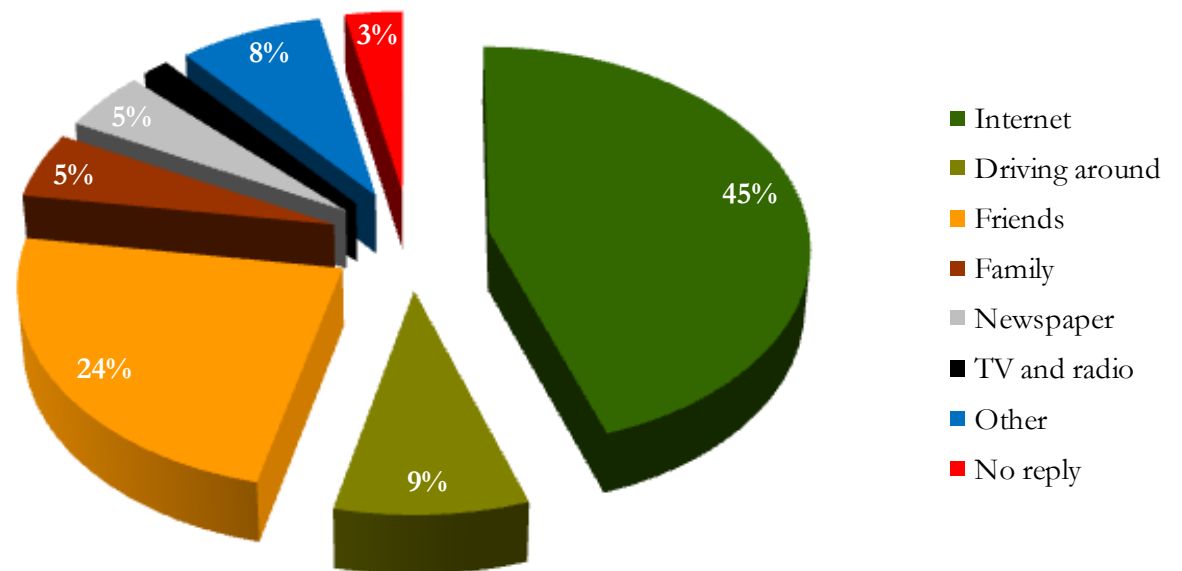
Overall, 45 percent of all survey respondents said they most often get their information pertaining to leisure activities on the internet. This was by far the most frequently selected information source.

Other information sources cited by visitors included friends (24 percent) and driving around (9 percent). The driving around information source could point to promoting Colorado State Park awareness with increased signage throughout the state.

Newspaper and TV/Radio sources were not cited often by visitors as primary information sources.

SECTION 4: POTENTIAL PARK FEATURES AND PARK FUNDING

In Section 4, visitor survey respondents were asked to describe how they would feel about a number of potential changes that could be implemented at Colorado State Parks in the future. Other questions in Section 4 assessed visitors' general perceptions regarding Colorado State Parks and visitors' knowledge levels of funding sources of state parks.

Visitors were also asked to give their opinion regarding whether Colorado State Parks should receive funds from general state tax dollars.

VISITORS WOULD BE MOST PLEASED BY ADDITIONAL PARK LAND, TRAILS AND WILDLIFE OBSERVATION

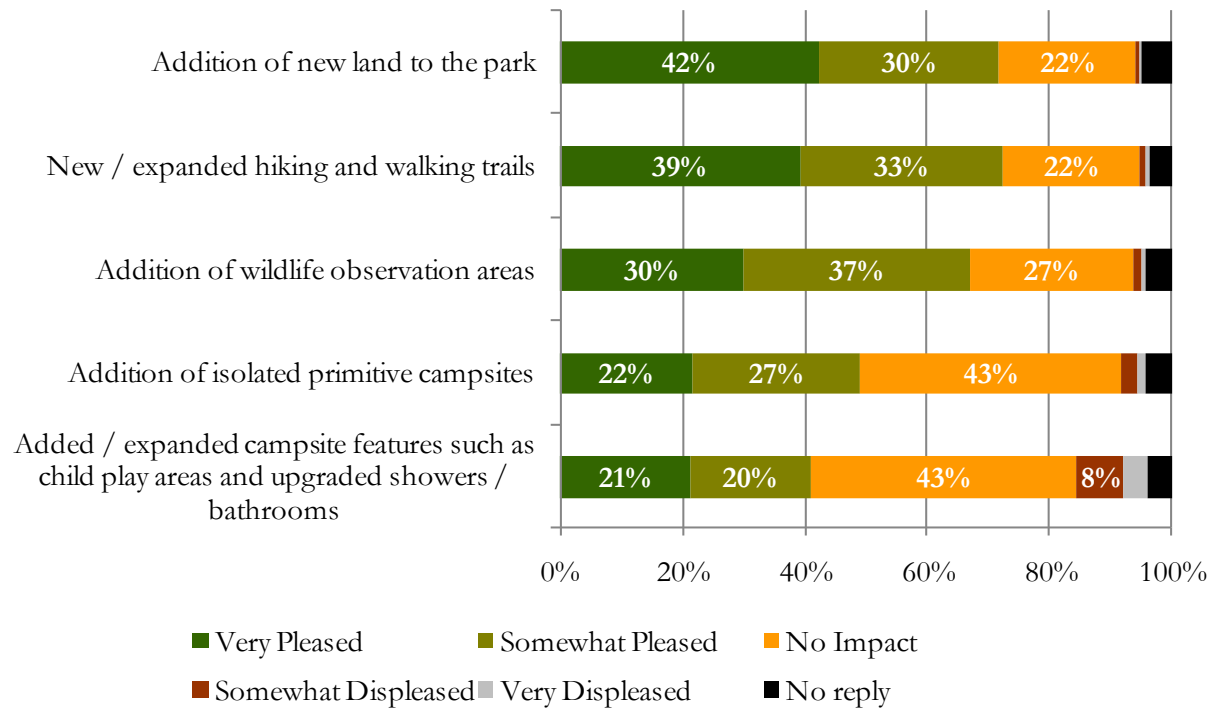
Overall, visitors were most likely to be pleased with the following potential changes to Colorado State Parks: Addition of new land to the park (72 percent at least somewhat pleased); New / expanded hiking/walking trails (72 percent at least somewhat pleased); Addition of wildlife observation areas (67 percent at least somewhat pleased).

Almost half of all visitors said additional isolated primitive campsites would please them.

It should be noted that though 40 percent of visitors said they would be pleased with added campsite features like child play areas or upgraded showers, a little over one-in-ten visitors said this added feature would be displeasing.

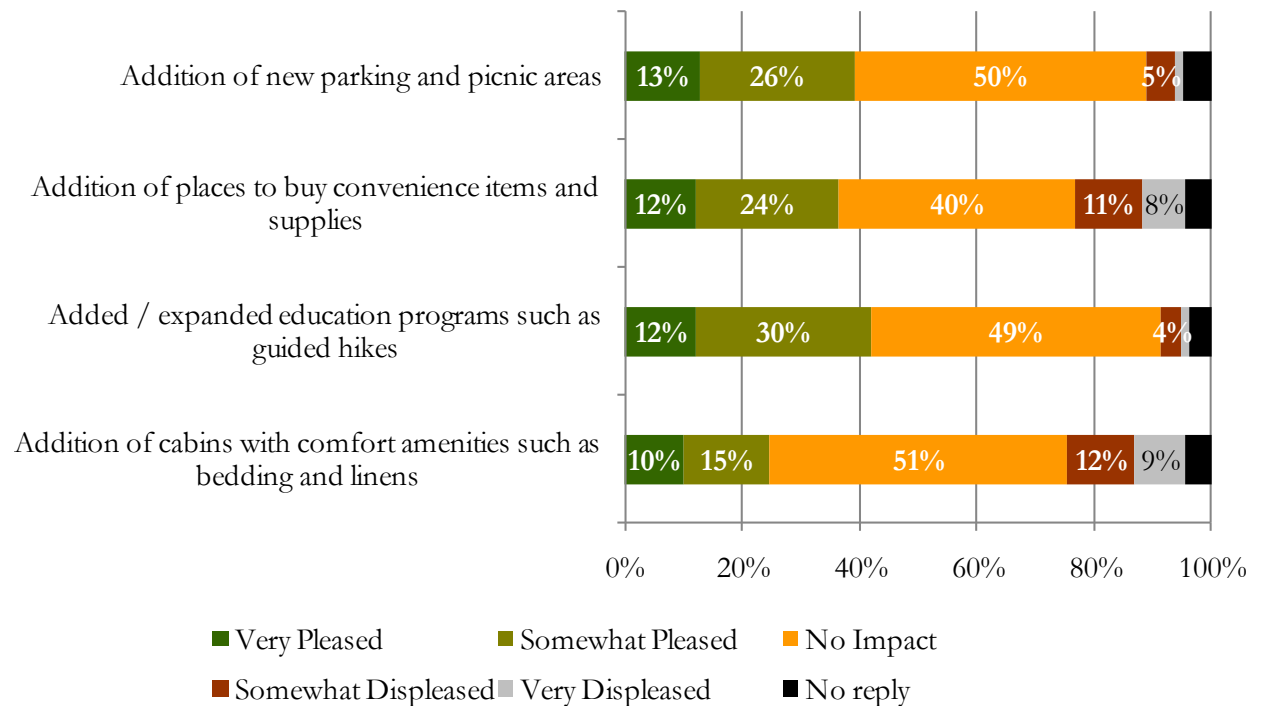
SUPPORT FOR COMFORT AMENITIES AND NEW PLACES TO BUY CONVENIENCE ITEMS WAS MIXED

Over one-third of all visitors said they would be at least somewhat pleased with the addition of new parking/picnic areas, additional places to buy convenience items/supplies and added education programs such as guided hikes.

Significant proportions of visitors were also likely to be displeased with the addition of cabins with comfort amenities like bedding and linens and the addition of places to buy convenience items and supplies.

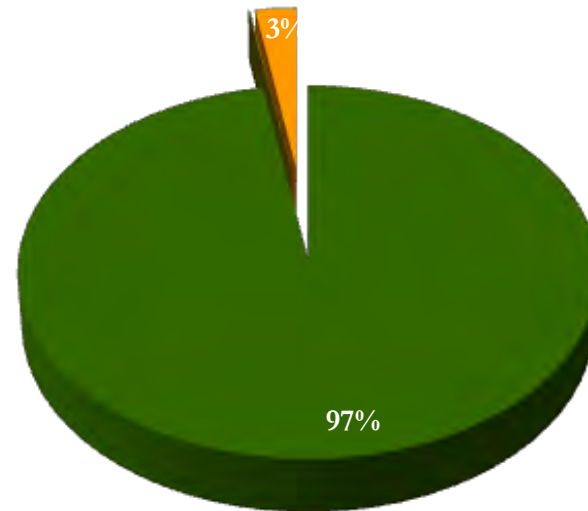

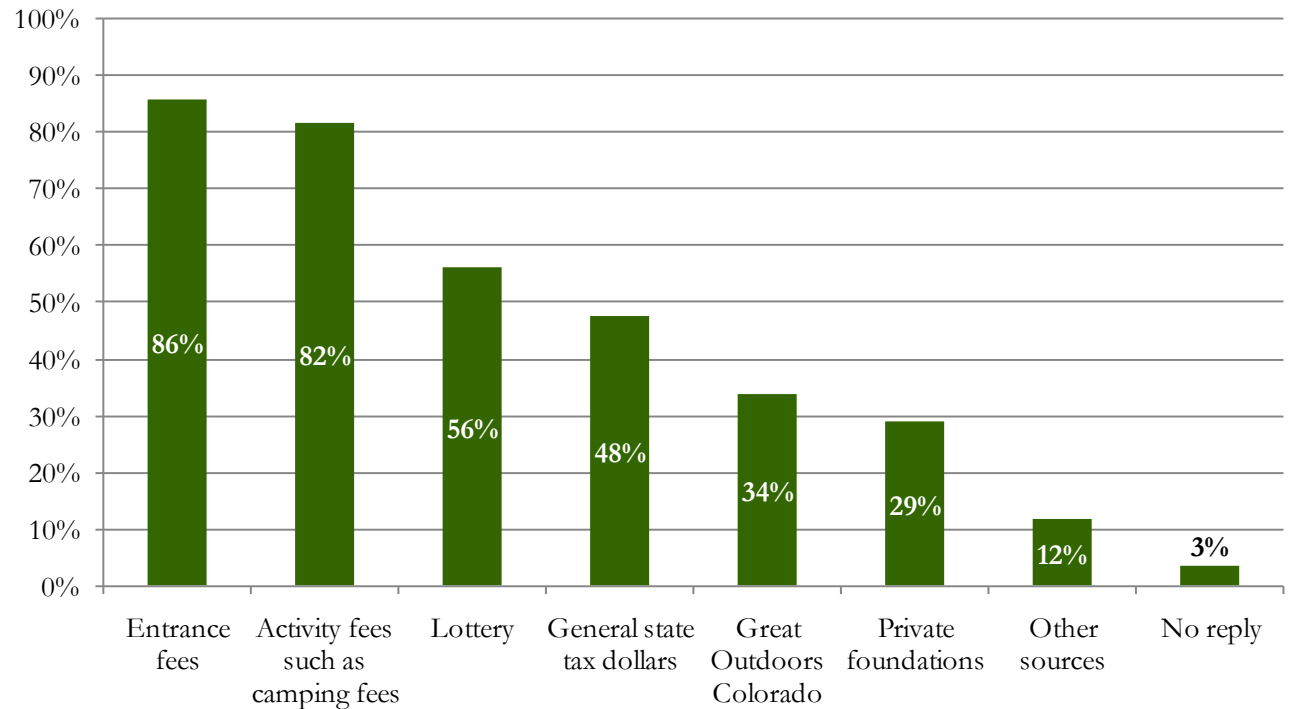
When asked what types of funding sources they thought were used to support Colorado State Parks, visitors most frequently identified entrance fees (86 percent) and activity fees (82 percent).

The lottery was also cited by over half of all visitors and general state tax dollars were cited by 48 percent of visitors.

Roughly one-third of visitors thought that Great Outdoors Colorado was a funding source.

(Question 27) From what you know about Colorado State Parks, what types of funding sources are used to support the agency?



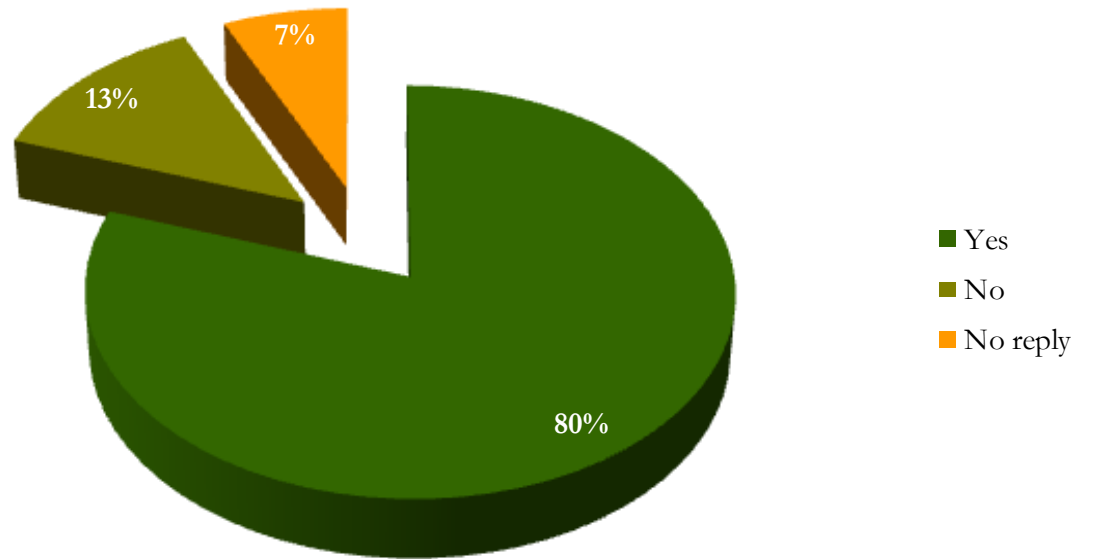

In Section 5, respondents were asked a number of demographic questions. These questions included gender, marital status, and the number of children living in respondents' households, age and ethnicity.

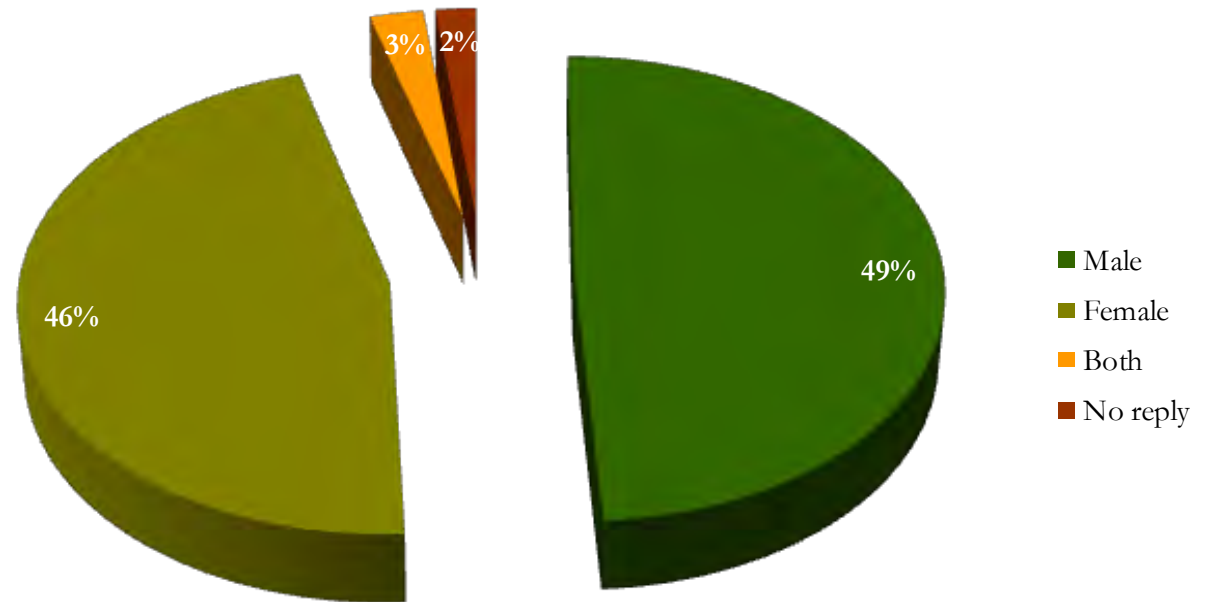

(Question 29) Gender (of the person answering this survey)

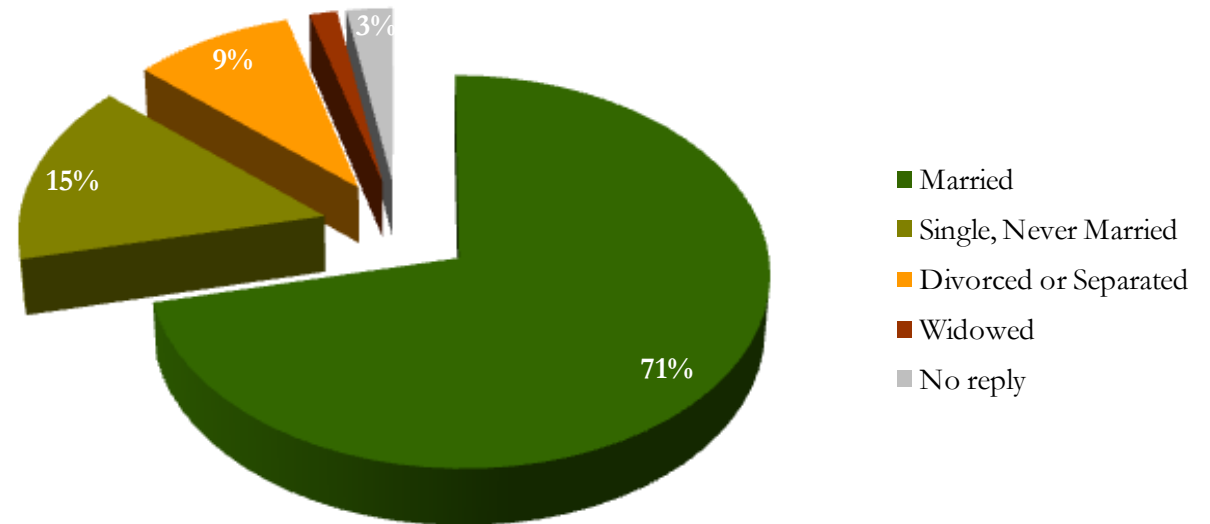

(Question 30) What is your marital status?

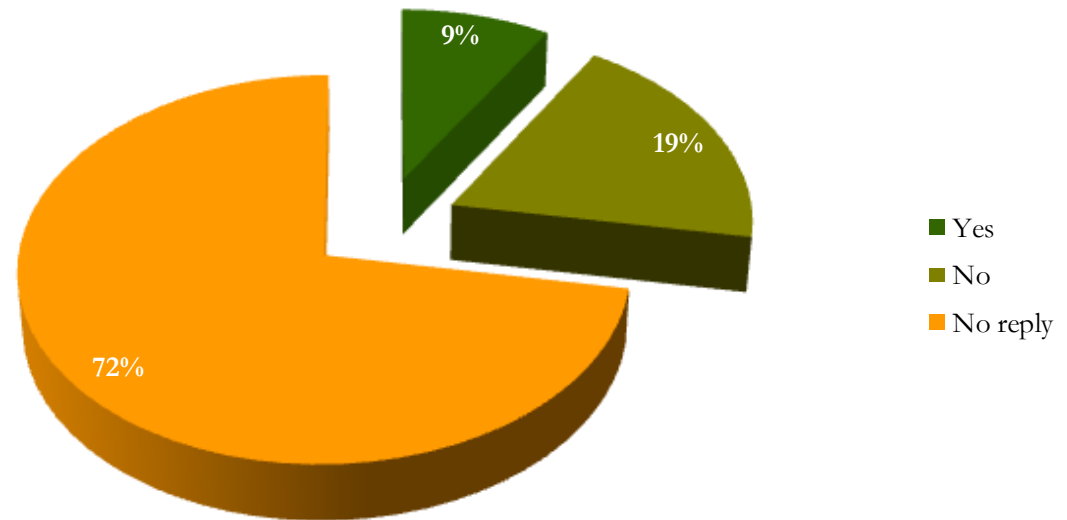

(Question 31) If not married, do you live with a “significant other”?

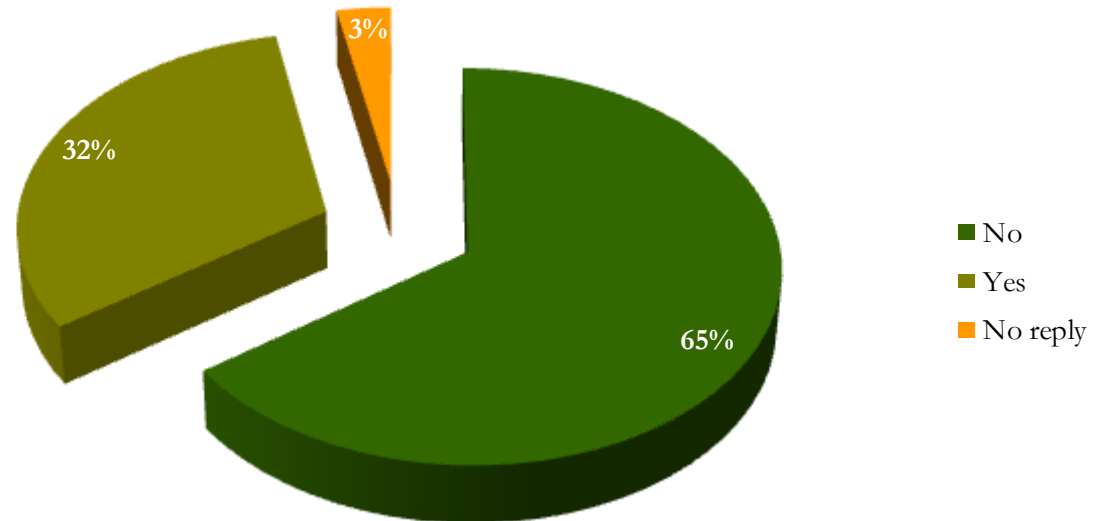

(Question 32) Do any children under the age of 18 live in your home?

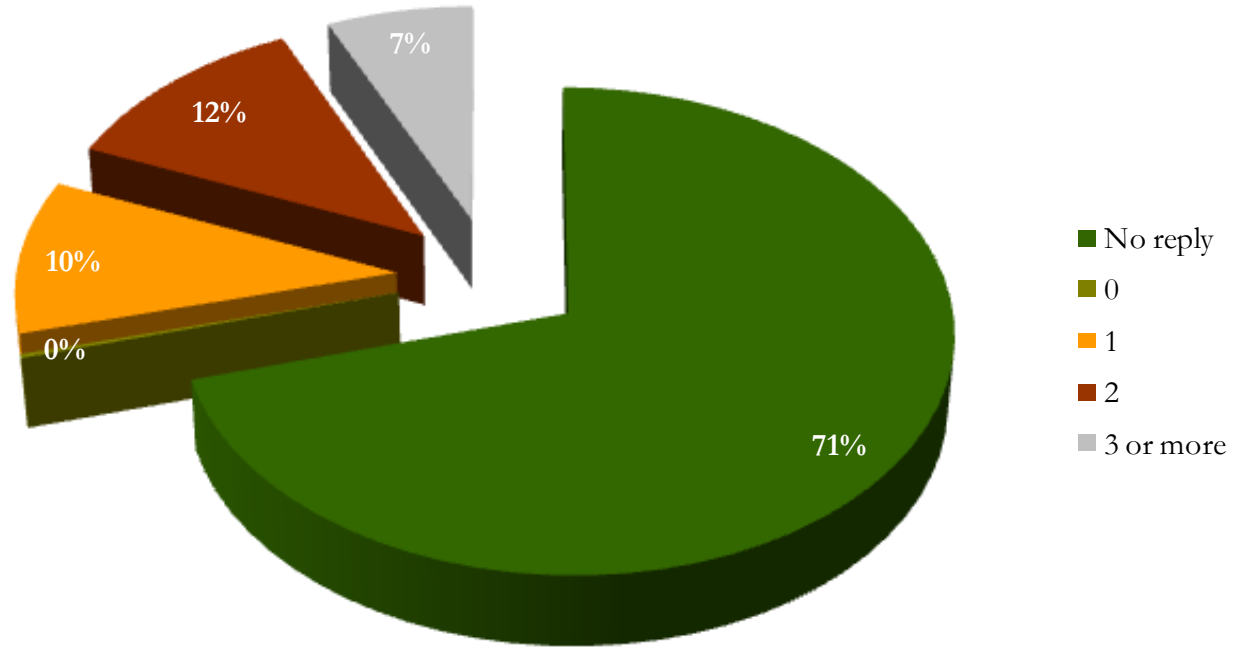

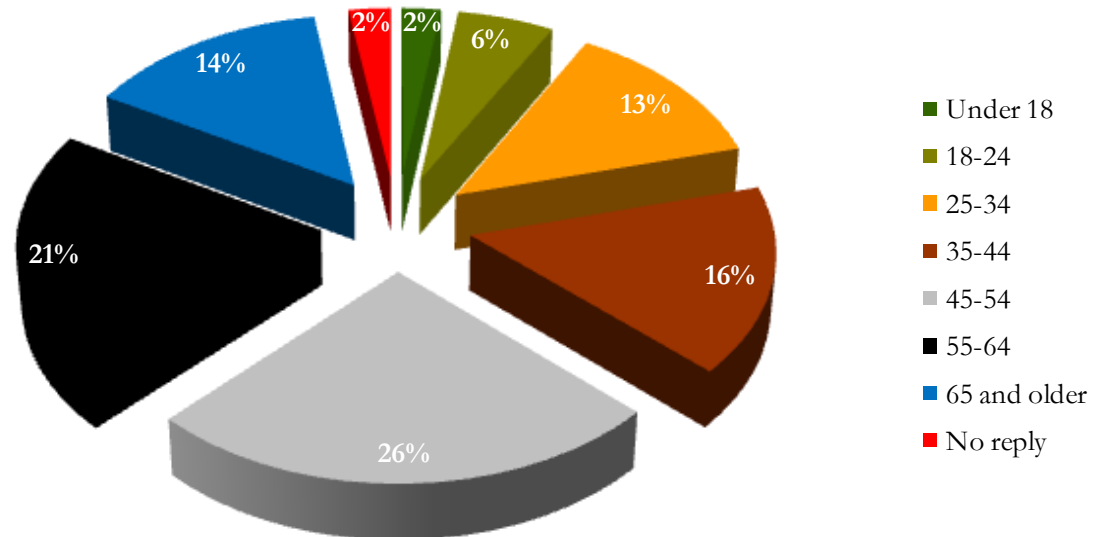
Overall, the most commonly surveyed visitor survey respondent was between 45 and 54 years old (26 percent).

(Question 33) Which of the following categories includes your age?



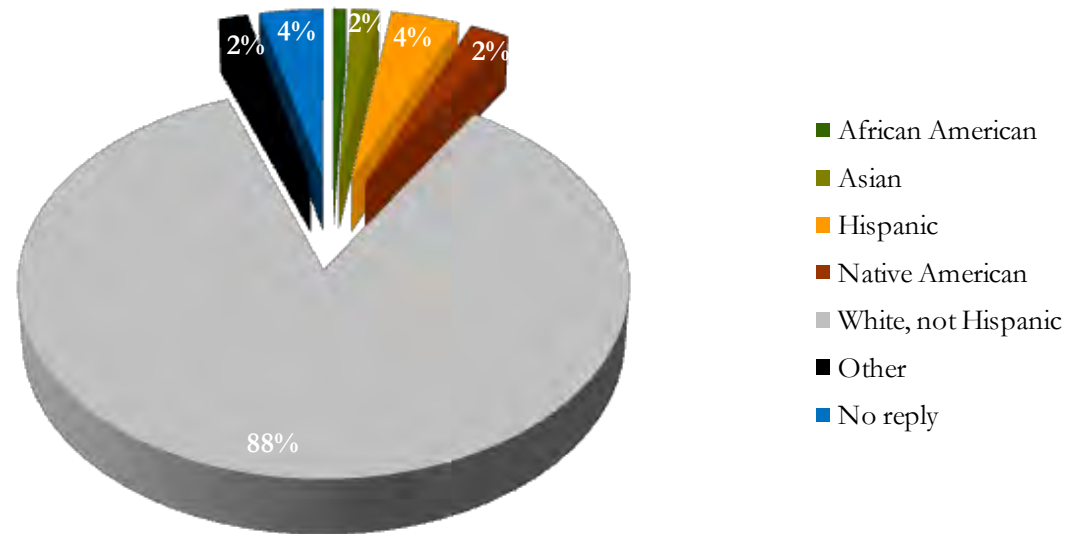
A LARGE MAJORITY OF VISITOR SURVEY RESPONDENTS WERE WHITE
