



**WAGON WHEEL  
CAMPGROUND**  
BONNY LAKE STATE PARK

**GENERAL INFORMATION**

Located at the heart of Bonny Lake State Park, Wagon Wheel Campground is open year-round for your enjoyment. The Marina, boat launching ramps, wet slips and a fish-cleaning station are all within easy walking distance.

Wagon Wheel features 87 campsites, both pull-in and pull-through, with paved roads and parking spaces. Due to low water conditions, the lake is over 300 yards away from the campground. All sites are naturally shaded or have shade shelters over the picnic table. Picnic tables and fire grills are provided.

**ELECTRICAL SITES**

All campsites in Wagon Wheel Campground are equipped with 110 volt; 20, 30 and 50 amp service with standard RV and household style plugs.

**VISITORS WITH LIMITED MOBILITY**

Wagon Wheel Campground offers accessible facilities for people with limited mobility. Sites 66 and 80 are fully accessible and are connected to accessible toilets and water hydrants. Showers in the camper services building are equipped with benches and are accessible also.

**RESTROOMS, SHOWERS & LAUNDRY**

Wagon Wheel Campground offers two flush restrooms. The main facility, containing eight coin operated showers and laundry, is located near the campground entrance. A smaller flush restroom without showers is located closest to Loop D. A vault-type restroom is located in Loop G. The shower building is open year round.

**POTABLE WATER**

Wagon Wheel offers drinking water year-round with water hydrants in each loop.

**TRAILER HOLDING TANKS**

A clean-out station is located near the main entrance.

**PET PROTOCOL**

- Pets are required to be on a leash, not exceeding six feet in length, at all times.
- Clean up after your pet. Always carry a few plastic bags with you. You can also collect trash and debris you find as you walk with your pet.
- Pets are not allowed on swim beaches.
- Leave barkers at home.
- Keep pets away from other animals. Parks are home to a variety of wildlife. Respect their natural habitat and keep pets away from nests and other animal homes.

Reservations are recommended if you are planning a weekend visit or an extended stay of more than two nights. Reservations can be made year-round by calling the reservation numbers listed above. Reservations can be made three to 180 days in advance of your visit. A non-refundable fee is charged for each reservation.

Campsites not reserved are sold on a first-come, first-served basis and require immediate occupancy.

**CAMPSITE CAPACITY**

Each campsite is limited to one camping unit per site and a maximum of six individuals. A camping unit is defined as a passenger vehicle with two tents or a trailer, motor home, pickup camper or van camper with one additional tent.

**USER FEES**

Every motorized vehicle entering the park is required to have a current "annual" or "daily" park pass.

**Annual Park Pass:** \$60.00  
**Daily Park Pass:** \$6.00

Camping fees are additional to the park pass requirement on vehicles.

**Daily Camp Permit with Electricity:** \$18.00

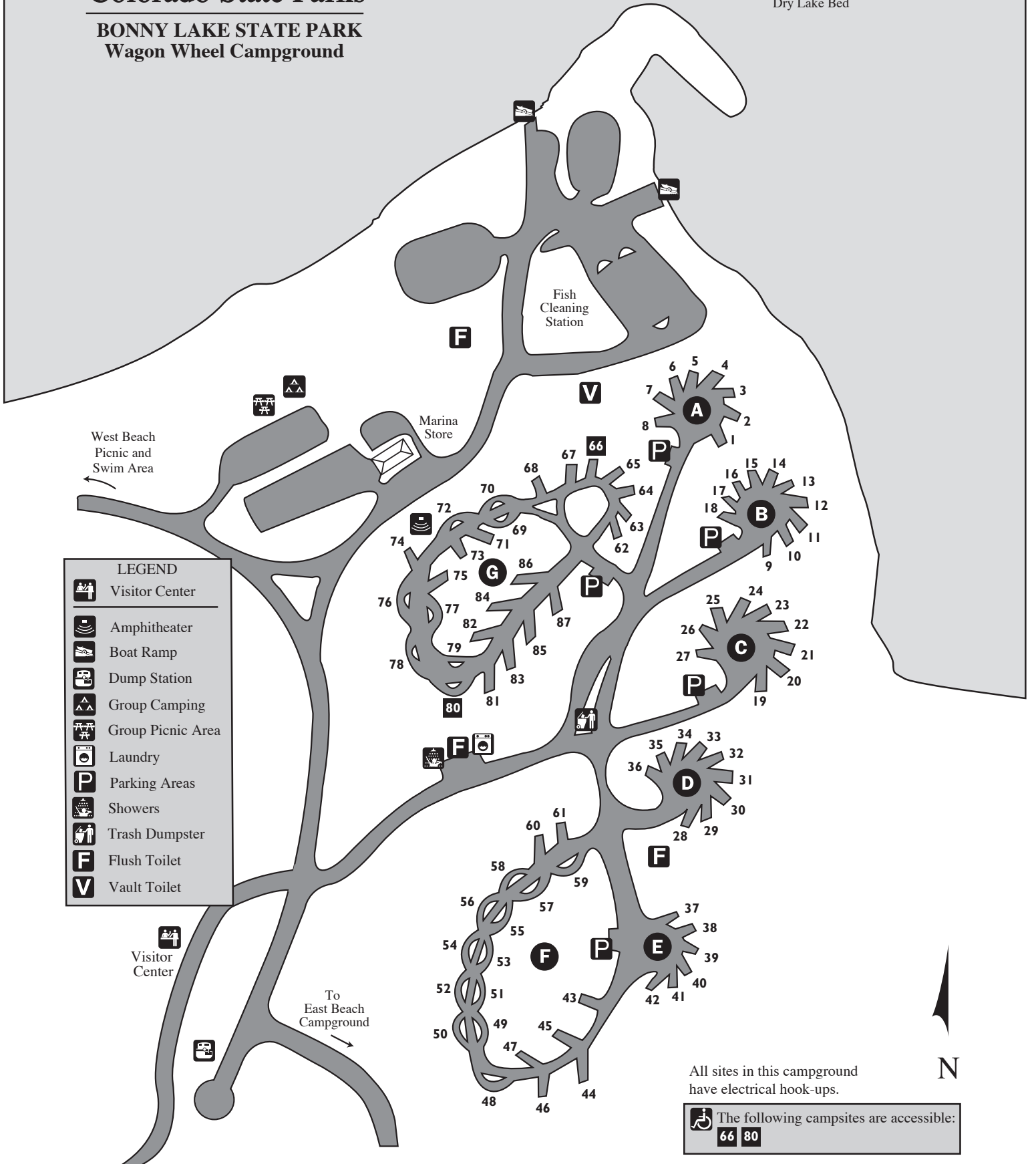
